Those members who are not participating at present can still sign up and contribute £4.50 monthly although a 12 month waiting time will apply before they are eligible for treatment. Although this restriction appears off-putting, one only has to consider the cost of current physiotherapy, consultancy and treatment fees to see the benefits of membership. # Things modest officers keep to themselves – but should they?

While looking for events to put into the Newsletter, I recently asked members to offer events that might be of interest. One member did respond and suggested an event he was involved with might be of interest. In his own words, he did not normally talk about things like that and felt putting it in the newsletter now was not like boasting as, his wife told him, it was now ancient history and of no real interest to people. I disagree and with his permission give a brief synopsis of two events that led to a young off duty **Constable Bob Crawford** being commended for his courageous actions.

#### Incident 1

The incident occurred when PC Willie Nimmo and Bob were on duty in Raploch about midnight one night in 1968. They received a report of a house fire in Raploch Road in the old-style houses, a block of four flats with central close and stairway. Ambulance and Fire Services had been notified but they arrived first and found the fire was in the bottom right flat and neighbours told them it was occupied by a single male occupant. They went in and flat door was unlocked so they crawled into the living room where all the smoke was coming from and found the occupant lying unconscious partly on the sofa. The fire appeared to have taken hold on a nearby armchair. They grabbed the man and dragged him out of the flat and carried him on to the pavement where they found two Army corporals who were passing on their way back to Drip Camp. They said they were First Aid trained and took over the casualty while Willie and Bob went back and very quickly checked other rooms

to make sure there was no-one else in the house. Ambulance and Fire Brigade arrived and fire was quickly extinguished and confined to the living room.

The occupant recovered and the cause of the fire was a surfeit of alcohol and a dropped cigarette which set the armchair alight.

Both PC's Nimmo and Crawford were surprised later when they were commended in the Chief Constables Monthly Order. They were also awarded Certificates from the Society for Protection of Life from Fire and had to go to the Town Offices to be presented with their certificates. The two army lads were also commended for their actions at the same ceremony.

The presentation was also notable as after it they were offered a dram or two from the Provost and were on the point of refusing, as they were in uniform, when Superintendent Willie Rennie gave them permission to accept. Bob said that was the only time that happened in his entire career! A couple of weeks after the incident, the occupant of the flat, whose name he can't remember, came down to Raploch office and thanked them both personally which they appreciated.

#### Incident 2

While Bob was on holiday in Macrihanish, Argyll, he heard cries of help coming from a 10 year old girl who was obviously in difficulties in the heavy seas. He immediately swam towards her and caught hold but lost his grip when a wave hit him. Another swimmer also came to assist and together they managed to pull the girl to safety. Unfortunately, another swimmer, a middle-aged man, who also tried to assist in the rescue, drowned.

Bob was awarded the Royal Humane Society's Testimonial on Vellum for his brave actions, as was his wife Catherine, who was also assisted in the rescue.

## **JACK WARDROPE**



Jack Wardrope was born in Stirling in 1945. His father was a policeman in Stirling and Tullibody. Jack attended primary school at Tullibody and secondary school in Alloa. On leaving school he took up employment with an engineering firm in Alloa but then joined the Stirling and Clackmannan Police Force and was stationed at Falkirk.

After a few years in the Police he left and returned to the engineering work but then came back into the Police Force. He was stationed at Stirling before becoming a Detective Constable in the CID at Stirling. He was then promoted to the rank of Detective Sergeant and stationed at Stirling.

A few years later he was promoted to Detective Inspector and posted to Alloa. His final promotion was to Chief Inspector when he became the local Unit Commander. Before retirement he was transferred to the Professional Standards Department. He retired from the Police in 1999.

Retired life did not mean an easy time for Jack as he took up employment as a store delivery driver and worked in a garden centre to name but a few aspects.

Unfortunately, retired life was not kind to Jack as he suffered from several serious illnesses which resulted in stays in Forth Valley Royal Hospital, Queen Elizabeth Hospital, Glasgow and finally in Strathcarron Hospice where he died on 28th February 2025.

One of his main hobbies was model railways and as such he was a member of the Bonnybridge Model Railway club. He was interested in how to wire the layouts and was an avid builder of cottages etc for the layout.

He was a well-respected individual and this was reflected in the number of people who attended his funeral at St Ninians Parish Church on Tuesday, 18<sup>th</sup> March, 2025. We extend our sympathy to his wife, Jean and the family.

## YVONNE GEDDES


Yvonne sadly passed away on Thursday 20th March 2025.

## **GEORGE MATCHETT**



George Matchett was born in 1943 at Alloa and after schooling he took up employment with the National Coal Board, working in Alloa. He subsequently joined the Police in 1966 and did his initial training at Alloa and Stirling where he served on the street as a constable and then in the CID as a Detective Constable. He rose through the ranks and became the Superintendent at Stirling and then the Chief Superintendent at Falkirk. He was thorough and methodical in his Police work and would often arrive for work before the nightshift finished. He will be remembered for his work in setting up the Major Incident Control Room at Grangemouth and for his administration capabilities in dealing with the Polmont Train Disaster, on 30<sup>th</sup>

July 1984, the Tornado aircraft crash at Glen Ogle on 2nd September 1994 and a number of Major Incidents at Grangemouth Petro Chemical Complex.

George was firm but fair in dealing with officers and when an officer wanted his assistance, no matter what time or day or night he would be there to answer the call and give advice. Even after retiring from the Police he still had the Police interest at heart and went on to become a Councillor with Clackmannan Council and then Chairman of the Joint Police Board.

Sadly, his wife Ann died in 2023. We pass on our sympathy to his daughter Kim and the family.

## **GORDON MCKENZIE**



Gordon McKenzie was born at Airthrey Castle Hospital, Bridge of Allan on 21st April, 1956. He was educated at Alloa and on leaving school he had the option of taking up an apprenticeship or becoming a Police Cadet. He chose the latter.

His police career began in Stirling and there he met and married Linda (daughter of Sgt Tom Tosh). They started off life in Cambusbarron and later moved to Callander where he was promoted to Sergeant and later Inspector. During his time in Callander, he was a keen walker and became a member of Killin Mountain Rescue Team and also a member of the Underwater Search Unit. He was actively involved in the Callander Round Table and Rotary and enjoyed participating in their activities. Gordon was a keen

fisherman who, due to his location only had to step out the front door of his house which led directly on to the River Teith.

He was actively engaged with the RPOAS walking group and gave conducted walks around the Callander area. Sadly, his health deteriorated and he was in hospital on several occasions. He died on 27<sup>th</sup> March 2025 in Strathcarron Hospice. We extend our sympathy to his wife Linda and their family.


Police but this only lasted a short time when he transferred to Central Scotland Police. He was stationed at Falkirk and later promoted to Sergeant and stationed at Alloa and the Hillfoots area.

He was a member of the Scottish Strathspey and Reel Band, the Milton Fiddlers and the CSP Ceilidh Band performing with others at various venues throughout the area. On retiral Bert started up a motor servicing business in Tillicoultry and this passed on to his son when he retired from the Fire Service. It is now in the hands of Bert's grandson. For the past 10 years Bert suffered from Motor Neurone Disease which got progressively worse and as a result he was unable to play his beloved fiddle although he still enjoyed listening to Scottish Dance Music.

Bert sadly passed away on 12th April 2025, and the Branch pass on their condolences. His funeral took place on Tuesday, 29th April 2025 at Stirlingshire Crematorium and was conducted by Peter MacDonald (ex CSP).

## STEWART MARSHALL



Stewart Marshall was born on 24th April 1950 at Sauchie, Clackmannanshire. He attended Sauchie Primary School and High school in Alloa. On leaving school he took up employment as an apprentice with a local firm where he met his wife, Sandra. Stewart and Sandra were married on 25th April 1970, and shortly thereafter they obtained employment with North British Hotels, working at various locations throughout Britain, ending up at the Adelphi Hotel in Edinburgh. At this point Stewart got to know a local man who played the pipes and Stewart's interest in piping grew. Stewart also obtained experience as a Chef and learned management at the hotels. However, Stewart then left the hotel industry and joined the Stirling and Clackmannan Police where he was given a police house in Cornton where, with his

wealth of experience, he used to work on his car and his neighbours' cars at the garage which was attached o the Police House. His Chef experience also shone out as on one occasion he obtained a deer which had been killed and he butchered, skinned and cut the beast up. All of the officers in the six houses got a parcel of venison with Stewart's compliments. I know that this a true story because I got a parcel of venison from him.

Stewart was fortunate in then getting a Police House at Cambusbarron and when he purchased it, he decided to extend the house. He got books about house building and eventually built the extension himself, doubling the size of the house.

He was promoted to Sergeant and Inspector in the Traffic Department and was eventually in charge of the Traffic Department, the Underwater unit, the Mountain Rescue Squad, the dog section and the Firearms Department. He was later in charge of the I.T. Department. During this time, he continued with his piping and was a member of various pipe bands. He was then promoted to Superintendent at Alloa in charge of the Clackmannan Division from where he retired after completing 30 years police service.

Retirement was not in Stewarts's way of life and he was actively engaged in the work at the local church, cutting grass and doing all sorts of repairs. He was also a black belt in Karate and ran classes for the local youth of the area where he was also actively engaged in the local community centre. An avid fly fisherman, he spent many long hours afloat at Lake of Menteith in particular but also pursued this hobby in all 4 home countries.


Unfortunately, Stewart became ill and was given only months to live. However, such was his tenacity, the months became 8 years before he passed away on Easter Monday, 21<sup>st</sup> April 2025, just 3 days short of his 75th birthday.

His funeral took place on Friday 2nd May 2025 at Cambusbarron Church, and thereafter at the Stirlingshire Crematorium.

## **LESLIE CUMPSTEY**



Leslie Cumpstey (97) was the RPOAS oldest member. He was born on 1/9/1927 in Oldham and started his working life in a butcher's shop. He later joined the RAF and was stationed in Helensburgh where he met his wife. Leslie decided that they would stay in Scotland and he joined Stirling and Clackmannan Police in 1949. On regionalisation he remained with the newly formed Central Scotland Police and was stationed in

Grangemouth, Stenhousemuir and Larbert Police Stations. Sadly, his wife, who had suffered ill health, passed, away and later, Leslie met and married Jean. After 25 years service, Leslie was promoted to Sergeant and transferred to the Force Control Room, Randolphfield, Stirling, where he finished his service. At this time, Leslie had finally settled down in Fallin. It was here when Leslie suffered another sad loss where Jean, after a long illness, passed away.

He was an active member of the RPOAS and attended many functions. He particularly liked the Annual Seniors' lunches where he loved to reminisce old times.

Leslie's mobility worsened in later life and this prevented him from attending RPOAS events. Leslie passed away on Wednesday 14<sup>th</sup> May 2025 at Bellfield Care Centre, Stirling.

## THE ELIZABETH EMBLEM



On 11th August, 1967, Constable Joseph Stewart DRAKE, aged 36 years, of Stirling and Clackmannan Police Force, was on duty with Constable John NELLIES, in the Eastern Division Crime Car when they received information that a stolen lorry was being pursued by other Police vehicles. They established a road block between Bonnybridge and Dennyloanhead but the driver of the stolen lorry intentionally struck their car as they tried to intercept it. Joe Drake was killed while his colleague escaped with severe shock.

Constable Drake, who was then stationed at Falkirk, had joined the police in 1953, serving first at Falkirk then Stirling, Causewayhead and Drymen before Falkirk once more. His name is recorded on the roll of honour at the Scottish Police College memorial at Tulliallan.

On Friday, 4th July, 2025, it was announced that Joe Drake's (pictured) relatives are to receive the Elizabeth Emblem which is an award to be given to the relatives of the civilian forces and other occupations who had been killed on duty. An official presentation of this award will be made in the not too distant future.
